**RIDER CHECK-IN (REQUIRED):** On Race Day at the Alpine Inn (Cross the footbridge from the Crystal Mtn. Lodge Parking Lot). Check-In Begins at 8:30 AM and Ends at 10:30 AM.

**START TIME:** First Rider Departs at 11:01 AM, with Others to Follow at Thirty Second Intervals.

**ENTRY FEE:** \$30 per Rider (\$20 for Juniors) (Includes \$3 USCF Insurance Fee & WSBA Equipment Fee)  
Additional \$10 for One-Day USCF License for Non-USCF members  
Additional \$10 for WSBA Rental Number for Non-WSBA members (of which \$5 is refundable)  
For Out-of-State Riders there is no fee to rent a Number, just a \$5 deposit

**PRIZES:** \$50 Each for the Fastest Overall Male and Female Riders \*\*  
Championship Medals Awarded 3-Deep for each WSBA Category Group & Age Group

**LOWEST TIME / WEIGHT RATIO (SECONDS/LB):** Weight Will Be Measured At The Finish. Separate Awards (\$30) For Men and Women.

**DRIVING DIRECTIONS:** Take HWY. 410 East From Enumclaw Approximately 30 Miles. Turn Left at the Crystal Mountain Turnoff. Follow the Crystal Mountain Boulevard to Its End at the Crystal Mountain Lodge Parking Lot (Lot A). Check-In for Pre-Registered Riders Will Take Place at the Alpine Inn (Across the Footbridge). We Recommend Parking at the Finish Line and Riding Down to the Start Line. Vehicles will be Available to Carry Warm-Up Gear Back to the Start Line. If You Choose to Park at the Start Line, Use the Gravel Parking Lot. **DO NOT PARK ON CRYSTAL MOUNTAIN BOULEVARD OR HWY 410; IT CAUSES DANGEROUS TRAFFIC CONGESTION IN THE START AREA.**
